How Does a Quality High School Building Benefit a Community?

- Quality school buildings facilitate quality education. Parents want quality education for their children and want homes in good school districts. Houses in desirable districts therefore enjoy increased property values, benefiting all property owners.
- Neighboring communities such as Bethel Park, Upper St. Clair, South Fayette, Baldwin and Mt. Lebanon have completed, or are in the process of renovating or building, new school facilities, increasing their attractiveness to potential home-buyers.
- An up-to-date facility can attract new revenue to the school district by having the ability to rent the auditorium, gym, etc.
- School violence affects an entire community. Being proactive and remedying <u>known</u> security problems helps reduce the risk and potential severity of school violence.
- Careful, long term planning remains the best way to address the needs of our school district. A short term, "band aid" approach is not effective and, in the long run, costs taxpayers more.

Building Issues

- Current building layout does not address today's safety and security concerns.
- Current classrooms and infrastructure limit our ability to capitalize on 21st century teaching methods and learning styles.
- Limited classroom space restricts course offerings.
- Inadequate lab space forces some science labs to use a cart with limited lab supplies and equipment, restricting the number of lab science classes offered.
- The lack of a high school life-skills classroom will impact our ability to provide adequate special education services for life-skills students.
- Feeding all students in the undersized cafeteria requires 4 lunch periods, starting at 9:45 am and lasting until 1:00pm.
- Over-crowding during class change presents safety concerns in the hallways and stairwells.
- With a seating capacity of only 700, the auditorium cannot accommodate the entire student body at once. The small stage and lack of an orchestra pit restrict our ability to rent this space.
- The gym capacity of only 1050 prevents the entire student body from participating in assemblies and pep rallies.
- Extensive infrastructure problems (e.g. leaking roof, original windows, electrical systems, and boilers from 1969) will be quite costly to operate and maintain.
- The lack of windows in many classrooms causes security and safety issues.
